PSI Joint Venture Part of New Pantex M&O Team

LAS VEGAS --- Mission Assurance Alliance, LLC (MAA), a joint venture of Paschal Solutions (PSI) and Longenecker & Associates (L&A), is proud to be part of the PanTeXas Deterrence LLC (PXD) team selected by the National Nuclear Security Administration manage the Pantex Plant in Amarillo, Texas.

PXD is led by a subsidiary of BWX Technologies, Inc., and includes Fluor; SOC, a Day & Zimmerman Company; and The Texas A&M University System. Along with MAA, other integrated small business subcontractors include TechSource, Inc. and Los Alamos Technical Associates.

"The NNSA Pantex facility and its mission are vital to America's nuclear deterrence strategy and national security. PSI, through our joint venture with L&A, is very excited and honored to be part of the PXD M&O team to help to ensure delivery of those mission critical programs and to enhance the future security of our country," Paschal Solutions President Lane Paschal said.

The Pantex Plant plays an important role in helping to manage the U.S. nuclear weapons stockpile. Work performed at the site includes supporting nuclear weapons life extension programs; nuclear weapons surveillance, assembly and dismantlement; development, testing, and fabrication of high explosive components; and interim storage and surveillance of plutonium pits. As part of the PXD team, MAA will provide support in mission assurance, quality assurance, project delivery and nuclear safety.

"We're proud to help ensure the safe and successful execution of the important work at the Pantex Plant," L&A CEO John Longenecker said. "This represents the first significant role for MAA and our partnership with Paschal Solutions in the NNSA complex, and we look forward to continuing our successful collaboration as we go forward."

The new Pantex contract is set to run for up to 20 years, with a total value of approximately \$30 billion. The contract has an initial term of five years, with three additional five-year option periods. PXD began transition activities on July 15, which are expected to be completed by Nov. 14, 2024.
